## **Terms and Conditions**

## Applicants must:

- Be a resident or property owner in the Town of East Fremantle.
- Attend a cloth nappy workshop facilitated by the Town of East Fremantle, City of Fremantle, or City of Melville (Proof of residency may be requested).
- Attendance must be within 6 months of application.
- The rebate amount will not exceed a maximum of 50%, up to the value of \$100 on eligible items.
- Eligible items include: All type of modern cloth nappies including all-in-ones, two-in-ones, swim nappies, sleep nappies, prefold/terry nappies, fasteners, inserts, boosters and liners
- Postage and other accessories such as wipes and wetbags, are not eligible for this rebate.
- Choice of hire through the Nappy Guru's Library or purchase through a company with an ABN.
- Purchase or hire must be within 3 months of application.
- Tax invoice must clearly state business name, purchase date, ABN, list of items and costs.
- Applications must include: Tax invoice for hire or purchase of modern cloth nappies and, proof of residency showing name and current address (e.g.: driver's license, rates notice, lease agreement).
- Application must be made to the Town of East Fremantle via the online form, or printed form can be:
  - Handed in person to the Town Hall 135 Canning Highway, East Fremantle
  - o Emailed to admin@eastfremantle.wa.gov.au
- Applicants will be notified on the outcome of the application by email.
- An application does not automatically guarantee rebate success.
- Successful applicants will have their cheque process up to six weeks after application.
